

Certificate of Exemption

Explanation of Variances from 2016/17 accounts

Section 1, Box 4.

Staff costs have altered due to pension auto-enrolment

1. A pension scheme was set up with The People's Pension and from the staging date on 1/4/16 Council has contributed 3.75% and Clerk 4.25% of gross salary to that scheme.
2. In November 2015 Council agreed the sum of £595-33 (being the sum due had Council put money to one side from 1/12/2006 to 31/3/2016 for a 3.75% clerk's gratuity) be earmarked in Council's reserves and transferred to the pension in full during the 2016/17 financial year.
3. The accrued sum of £595-33 held within reserves as funds earmarked for staff retirement benefit scheme was transferred into the pension scheme during 2016/17.
4. In the year of account, employee's pension contributions totalled £83-28 and employer's pension contributions totalled £73-56.

Section 1, Box 6.

Total expenditure in 2017/18 was broadly the same as 2016/17 (£5,513 as against £5,510). The decreases in staff costs (see above) were mirrored by an increase in grants (£500 to library and £150 to Citizen's Advice).

Level of reserves

Council kept the 2017/18 precept at the same cost for a Band D property as the previous year, however due to additional properties falling into the rating list, this resulted in an additional income of £35. Councillors are reluctant to decrease the cost to a Band D property and while they had previously noted the external auditor's advice on the 2016/17 Annual Return that Council should have regard to the level of reserves held when considering future precept requests, councillors chose not to act upon the advice.

However when setting the 2018/19 precept, councillors finally took heed of the advice of the external auditor and RFO and agreed to reduce the 2018/19 precept by over 17%, so a Band D property will be paying £14-31 in 2018/19 instead of £17-37 for 2017/18. While reserves are still higher than I would like, they should at least decrease in the long term.

In a very small council such as this, single figure percentage changes on a precept alter the figure very little. It is felt prudent to have a reserve in the region of £9,000 in order to cover a full year's expenditure and provide a sensible amount for unforeseen contingencies such as election costs or funding of projects which will benefit the parish.

For the financial years 2017-18, 2018-19 and 2019-20 Council is providing funding of £500/year to Newby & Scalby Library which serves the parish. From 1/4/2017 the library has been run as a registered charity by trustees and volunteers and Hackness & Harwood Dale Group Parish Council wanted to provide assistance. Council has budgeted to make this funding from reserves.
