General Notice of Registrable Interests 2012/13

I,

being a Member/Co-opted Member of Hackness & Harwood Dale Group Parish Council, give notice in this form of those interests which I am required to declare under The Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and Hackness & Harwood Dale Group Parish Council's Code of Conduct.

I understand that I must also declare any interest of a 'relevant person' (my spouse or civil partner, or of any person with whom I am living as husband or wife or as if we were civil partners) on sections 1-6 of this form, as defined in the Council's Code of Conduct.

I have also declared my personal interests as required by the Code of Conduct, as shown on section 7 of this form.

<p>Any gifts or hospitality worth more than an estimated value of £25 which you have received by virtue of your office</p>

2	<p>I understand that failure (without reasonable excuse) to register or disclose any disclosable pecuniary interest in accordance with Section 30(1) or 31(2), (3) or (7) of the Localism Act 2011, or participating in any discussion or vote in contravention of Section 31(4) of the Localism Act 2011, or taking any steps in contravention of Section 31(8) of the Localism Act 2011 is a criminal offence and risks a fine not exceeding level 5 on the standard scale (currently £5,000) or disqualification as a Member for a period not exceeding 5 years.</p>
