Cllr. Lockey reported 1] the blocked gutters at Wrench Green [Minute 64/16 refers] had still not been sorted, 2] the road on Hackness lakeside was a disgrace when it rained and 3] the grass verge through Forge Valley was in need of cutting. Clerk to pass 1 and 2 to Highways, and contact East Ayton Parish Council re. 3. Cllr. Foxton outlined villagers recent problems with a speeding vehicle & asked if the road could be made a Quiet Lane (as were similar roads in East Yorkshire) - Clerk to contact Highways.. He also asked when Scarborough Borough Council was going to convert its parking meters to take the new £1 coins - Clerk to contact SBC. Cllr. Mrs Hugill reported the hedge at Wyatts Cottage was still overhanging the pavement to such an extent that pedestrians had to walk into the road - Clerk to contact Highways.

- 1] NYM/2017/0289/FL Renovate existing outbuilding for storage at 2 Hill Cottages, Keasbeck, Harwood Dale - **agreed** no objections;
- 2] NYM/2017/0404/FL Erect replacement 15m. mast with antennae and ground based cabinet at Everley Wood corner, Mowthorpe - **agreed** no objections;
- 3] NYM/2017/0448/FL Construct first floor extension over existing conservatory at 5 Darncombe Bungalows, Langdale End - **agreed** no objections;

- 1] NYM/2017/0046/FL Convert redundant building to form office, refurbishment work to workshop including installation of solar panels and rooflight, re-roofing works & re-glazing of granary windows together with alterations and extensions to dwelling at White Lodge, Langdale End - **granted**;
